**I) Public Hearing**

T-Mobile requests a special use permit to co-locate on the Textile Road Cellular Tower.

The Township Planner Don Pennington states that the request is acceptable. The Township Engineer Ron Cavallaro Jr. requests that 3 items be taken care of:

- the applicant's licensed engineer approve the plans and verify that the plans are in compliance with all applicable standards, specifications, and regulations.
- Identification of the entities providing the backhaul network.
- verification that state and/or federal regulations concerning nonionizing electromagnetic radiation will be adhered to.

Moved by Thelen, seconded by Diuble, that the Public Hearing be closed.
