**2007 PROPERTY TAXES MAY BE PAID BY:**

- ➡ **U.S. Mail** - allow enough time to be received in the Treasurer's office by February 14, 2008.  
Payments **received after** February 14th will be delinquent. A Township receipt will be mailed if a self addressed stamped envelope is included with payment.
  
- ➡ **Township Drop Box** - (No postage required for Township's drop box)  
Drop Box is secure and located to the left of the double entrance doors at the township hall, available 24 hours per day.
  
- ➡ **Township Hall** - 3755 Pleasant Lake Road  
Office Hours 9:00 am until noon, Monday, Wednesday & Friday.  
The drop box may be used after regular hours.  
Extended hours in December: Open Dec. 28 from 9am - 5pm  
Open Friday February 8th from 9am to 3pm and Thursday, February 14th from 9am until 5pm.

**All DELINQUENT SUMMER 2007 TAXES will be collected with interest added as follows:**

Taxes paid December 1 - December 31st	Add 4% INTEREST
Taxes paid January 1 - January 31st	Add 5% INTEREST
Taxes paid February 1 - February 28th	Add 6% INTEREST

Deferred Summer taxes are due February 14th, 2008.

**AS OF MARCH 1, 2008: ALL DELINQUENT SUMMER AND WINTER 2007 TAXES WILL BE TURNED OVER AS DELINQUENT TO THE WASHTENAW COUNTY TREASURER'S OFFICE WITH PENALTIES AND INTEREST ADDED BY THE COUNTY ON MARCH 1, 2008.**

**DOG OWNERS:** 2008 Licenses are sold at the township Dec 1st to Feb. 28th. (March 1st - Nov. 30th licenses are sold at the County office)  
Bring or mail unexpired Rabies Certificate for 2008 license. Dog license fees are \$10, spayed or neutered are \$5.  
Senior citizens, 65 years or older, all dogs \$5.
