The regular meeting opened with the flag pledge. Roll call of the board.  
Present: Godek, Crowner, Lindemann, Foley, Rentschler, Radecki, and Masters.  
Also Present: Attorney O'Jack, and Planning Chair John Steeb along with 3 citizens.

Minutes of the September 12, 2006 minutes were approved with two small corrections as moved by Foley, seconded Crowner. Carried.

Terry Brinkman from Washtenaw County Planning presented a Purchase of Development Rights application from **Thomas Tobias** at 7564 Saline Waterworks Road, Saline, Lodi Township parcel # M-13-31-400-001. Moved Masters, seconded Lindemann to adopt resolution 2006-011 Supporting the Application to the Michigan Agricultural Preservation Fund and the Washtenaw County **PDR** Program for the Thomas Tobias property M-13-31-400-001, 7563 Saline Waterworks Road, Saline.  
Roll Call Vote: Aye: Foley, Godek, Rentschler, Lindemann, Masters, Crowner, and Radecki. Nay: None. Abstain or Absent: None. Resolution adopted.

The agenda was amended adding K-16 Ballot Proposal, MTA Conference, cleaning of the eaves on the township hall, and Terry Brinkman as moved by Masters and seconded Foley. Carried.

#### **UNFINISHED BUSINESS**

- 1. Lindow** - Mr. Lindow has filed a lawsuit against Lodi Township in Federal Court. No one has been served. Until someone has been served, there is no case.
- 2. Zoning enforcement officer.** Godek, Radecki, and Foley will work on a job description for a Zoning Enforcement officer.
- 3. Settlement Conference** - Peters Summit - December 12, 2006 at 1:45 p.m.

#### **NEW BUSINESS**

- 1. Road Right of Way Map** - Washtenaw County Road Commission submitted a draft of possible road rights of way that they feel will be needed in the future. The Road Commission requested a recommendation from the board by the end of this week. After much discussion, Foley moved to keep the road right of ways as they are today. Radecki seconded. Carried.
- 2. Dr. Hayes** – Supervisor Godek would like to have Lodi Township host a presentation by Dr. Hayes on Ground Water flow and Aquifers. Date established for the presentation is October 26, 2006 at 7:00 p.m. Surrounding communities should be invited.

**3. Fredrick Farms** – An application for an NPDES (private waste water plant) permit for 660 units on the Fredrick Farm on Wagner Road was referred to the township from MDEQ. This is a waste water permit for deposit of sewage into a county drain (Rouse). Moved Crowner, second Foley to not sign the permit application. Roll call vote: Ayes: Foley, Lindemann, Godek, Rentschler, Masters, Crowner, and Radecki. Nay: None. Carried.

**4. Local Bridge Program** – Moved Crowner, seconded Foley to not participate in the local bridge program . Roll Call Vote: Yea: Godek, Crowner, Radecki, and Foley. Nay: Rentschler, Masters, and Lindemann.

**5. Jessica Ping Mills** – introduced herself as a candidate for the office of 3<sup>rd</sup> District County Commissioner.

**6. Resolution 2006-016** – Moved Radecki, seconded Crowner to adopt a resolution in opposition of the ballot proposal K-16. Roll Call Vote: Yea: Foley, Crowner, Rentschler, Masters, Radecki, Lindemann, and Godek. Nay: None. Resolution adopted.

**7. MTA Conference** - Discussion on the annual conference that will be held in Detroit.

**8. Township Hall Eves** – Suggestion was to ask our handyman guy to do the cleaning out.

**9. Budget** – Moved Masters, seconded Radecki to move \$5000 from drain tax (101440:445) to hall maintenance and repair (101265:930). Carried.

**10. Payment of Bills** – Moved Radecki, seconded Foley to pay the bills presented totaling \$94,771.30. Carried.

**11. Adjournment** - No other business brought before the board, the meeting adjourned at 9:05 p.m.
