8. New Business

- a. Resolution 2013-001 Fireworks delegation of authority agreement. Resolution moved for adoption by Lindemann, seconded by Giezentaner. The resolution delegates fireworks inspections for Lodi Township to the Saline Area Fire Department who in turn agrees to the delegation with the Michigan Department of Licensing & Regulatory Affairs Bureau of Fire Services. Roll Call Vote: Aye: Rentschler, Giezentaner, Canham-Keeley, Lindemann, Foley, Godek, and Masters. Nay: None. Absent/Abstain: None. Resolution 2013-001 declared adopted.
- **b. Board of Review Members** Godek stated that all members are willing to serve another 2 years. Moved Canham-Keeley, seconded Foley to appoint the following Board of Review members for two year terms, 2013-2014: Dana Dever, Vance Shutes, Jane Chronis, and Dan Struble as alternate. Carried.
- **c. Budget Workshop** –The board set February 9, 2013 at 9:00 a.m. to hold the budget workshop.
- **d. Road Commission Annual Meeting** Godek stated that the road commission annual meeting is scheduled for April 2, 2013 at 7:00 p.m. prior to the regular township board meeting.
- e. 425 Agreement Discussion The pending annexation request by Keystone Community Church into the City of Saline was discussed. The State Boundary Commission would like to square off the township line. Lodi would be loosing several parcels of land along with the Keystone parcel on Saline Waterworks Road plus the island within the City of Saline. Many of the property owners as well as township officials attended a public hearing in December and voiced opinions. The hearing was to collect information. Several thoughts were presented. At this meeting a couple of residents on Saline Waterworks Road requested that the township send a letter to the commission opposing the annexation. In the discussion, the township board is willing to work on a possible 425 agreement in regard to the Keystone parcel. Godek will meet with the city to open discussion.
- **f.** Raisin River Watershed The watershed has lowered their dues and is requesting the township to again be an active member. Decision on paying the dues was postponed.
