5. **Planning Commission** – Planning Commission Chairperson gave a short report updating the board on the upcoming November Planning Commission Meeting. The upcoming meeting will include Frank Julian’s Private Road Application and the Pleasant Lake Road cell tower application and the continued work on the Zoning Ordinance updates.

 1. **Discussion regarding waving non-filing ~~if~~ of property transfer affidavits.**

On November 7, 2017 Trustee Foley made a motion to approve the non-filing fee of \$5.00/day up to \$200 maximum, seconded by Swenson. The motion was approved. Upon review of assessor records the new assessors are recommending we adopt a resolution waving this fee, due to the amount of PTA’s that have not been filed correctly, and are missing in the database. Because the Township was not properly advised by the assessor, and the lack of information to the public about when the PTA needs to be filed it would not be fair to charge a penalty.
 2. **Resolution #2018-014 A Resolution to Waive Penalties for Non-Filing of Property Transfer Affidavits under MCL 211.27b.** Motion Foley, seconded Swenson to approve Resolution #2018-014. Roll Call Vote: YEA: Rentschler, Schaible, Foley, Smith, Godek, Lindemann, Swenson. NAY: NONE. Absent/Abstain: NONE. Motion Carried 7-0.

3. **Discussion regarding recreational marihuana.** Discussion regarding ~~the~~ **new- Proposal 18-1 Recreational Marihuana** that passes on November 6, 2018. The law allows Townships to opt in or out of facilities licensing. If a Township doesn't do an Ordinance opting out of a facility, the state can, and possibly will give the Township a facility.
4. **Ordinance #2018-001.** Motion Foley, seconded Smith to adopt Ordinance #2018-001 Prohibition of Marihuana Establishments Ordinance MCL # pending per the State. Roll Call Vote: YEA: Swenson, Lindemann, Godek, Smith, Foley, Schaible, Rentschler, Swenson. NAY: NONE. Absent/Abstain: NONE. Motion Carried 7-0
5. **Huron River Watershed Membership.** Motion Schaible, seconded Lindemann to not become members for the Huron River Watershed Council. Carried 7-0.
6. **Snow Removal Quotes.** Two quotes for snow removal at Township Hall were received. At the meeting Trustee Lindemann offered to continue to plow and salt this year. Motion Foley, seconded Swenson to approve Trustee Lindemann to continue the snow removal and salting at the Township Hall. Carried 6-0, Lindemann abstained.
